## **Registration Form and Waiver and Release of Liability**

2. Release, waive, discharge, and covenant not to sue the Greenway Joint Recreation Board, its administrators, directors, agents, coaches, and other employees or the governmental units which participate in the Joint Recreation Board, hereinafter called "releasees" from any kind of liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses, or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or part by the negligence of the releasee or otherwise.
